

# Teaching Methods of China

#### • Teachers-oriented method

Teachers' duties are to give students large amount of knowledge and formalize their daily behavior.

#### • Advantage:

The contents are focused on theories, and students can have a command of basis.

#### • Disadvantage:

Students do what they are told to do. Most of Chinese students have no capability of self-discovery .

# Teaching Methods of Western countries

#### • Students-oriented method

Teachers' duties are to motivate and direct. Students have full freedom to interrupt and query their teachers.

#### • Advantage

Students have more motivation to figure out what they do not understand. The innovation and capabilities of self-study are cultivated.

#### • Disadvantage

Their classes are not formal enough and contents are simple. It's no good for their basic knowledge.

### > Normal examinations

Purpose : aim at finding out shortage and make it up After examinations: Teachers will hold a meeting with parents after the examination, and they will rank the grades and show the rank to all students.

### Western countries

## Normal examinations

Purpose : aim at obsoleting and higher education After examinations: The school reports are regarded as privacy. Teachers only give parents to see their own children's grades, results of will not be published.

#### College entrance examination

Gaokao (NECC, National College Entrance Examination) which can be acknowledged to decide one's future.

It's not dependent on any other things, but just on students themselves. It's an equal way to all the students.

### Western countries


#### College entrance examination
